FTI SHALL NOT BE RESPONSIBLE FOR THE COST OF ANY LABOR REQUIRED TO CARRY OUT THE REPAIR OR REPLACEMENT. - 3. IMPACT OF FOREIGN OBJECTS, FIRE, HURRICANE, TORNADO, OR OTHER VIOLENT STORMS OR CASUALTY, OR ACTS OF GOD.
- 4. DEFECT, FAILURE OF, OR DAMAGE TO THE WALL OR CEILING AGAINST WHICH THE INSULATION IS RESTING, CAUSED BY MOVEMENT, DISTORTION, CRACKING, OR SETTLING OF SUCH WALL OR THE FOUNDATION OF THE BUILDING.
